

**TTT MONEYCORP LIMITED**  
**CLIENT SURVEY PROMOTION – TERMS & CONDITIONS**

1. This promotion is open from 00:01 BST on 11<sup>th</sup> June 2026 and closes at 23:59 BST on 26<sup>th</sup> June 2026 (the **“Promotion Period”**) and is for the opportunity to receive up to £600 in your Moneycorp international payments account (**“Reward”**).
2. To be eligible for this promotion you must (a) be an existing Payment Solutions corporate client of TTT Moneycorp Limited (**“Moneycorp”**); (b) successfully complete the ‘client survey’ sent via email (the **“Survey”**) during the Promotion Period and (c) successfully complete foreign exchange transactions (**“Qualifying Transactions”**) within the amounts set out below (**“Aggregate Values”**), within a calendar month between July 2026 and September 2026:
